

After submitting this initial registration form, continue to submit invoices of Qualifying Products purchased through December 31, 2017 up to the maximum quantity limit allowed on rebate. All invoices must clearly indicate Qualifying Building Company name, name of Qualifying Product purchased, quantity purchased and price paid. All registration forms must be postmarked or faxed within 30 days of the purchase date listed on the invoice and received within 45 days of purchased date listed on the invoice to be eligible for rebate. Purchases made by homeowners on behalf of their builder cannot be accepted. Purchase must be made by professional building company to be eligible for rebate payment.
